**D. Reports**

- a. WWA Board of Directors - Scott Spindler was present and reporting. The Board has welcomed some parents attending their meetings this year. Charter renewal will happen next month and is expected to go smoothly. They expect an influx of families requesting to open enroll at WWA next year with several Jeffco schools closing.
- b. Staff Report - Bully Prevention Week and the Bully Prevention Carnival were last week. Each grade created a craft that was on display during the carnival, and over \$2,000 was raised. Middle School is preparing for some philanthropic holiday activities (sending cards to kids in the hospital or in foster care). They attended dinner and a play (Much Ado about Nothing), which went very well. The plan for the Intermediate renovation is still in process. Also hoping to renovate the art room this summer.
- c. Treasurer's Report - reviewed income and expenses for the school year so far.
- d. Secretary's Report - no report
- e. President's Report - PTO does not meet in December, so our next general meeting will be January 24th.

**E. New Business and General Q & A** - representatives from Boy Scouts of America presented about starting a Scout program in this area, potentially chartered by WWA PTO. Mrs. Bartusiak explained that WWA doesn't allow outside organizations to use the building after hours and asked if meetings could be held in other locations, which is possible. No decision has been reached yet, pending more community discussion.

Ms. Eisenburg requested funds for small-group curriculum for the lower grades, which can partly be covered through school curriculum and could partly be covered by PTO for sensory materials. Motion by Megan McFadden to approve \$100 for sensory tools, 2nd Christina Powell, motion passes as a post approved budget item.

Staff members representing the PAWS program have requested funding to expand prizes, and a regular raffle. Motion by Erin Mulligan to vote on a \$500 donation to the PAWS program, 2nd Janet Green. Discussion on how much is reasonable, given that most other programs don't receive that much and concern that PTO might not be able to fund that every year. Motion passes.
